Please join us for an evening of adventure as we explore *state-of-the-art* exterior and interior lighting installations at Naval Base Ventura County, Port Hueneme. The evening will kick off with dinner at an on-base restaurant (Nap's Southern Grill), followed by a tour of base facilities once evening comes around..

Tom Santojanni, your tour guide, will provide a brief description of each lighting installation along the way. The following technologies will be showcased:

LED - Roadway, parking lot, wallpack, gas station canopy, interior Lobby

Induction - Tennis courts, basketball court, parking lot, and car wash facility

Fluorescent - Interior highbay lighting installation (base gymnasium and weight room) which consist of fixtures lamped with 5000K (Spectrally-enhanced) T8 fluorescent lamps

Side-by-side comparison of LED and Induction parking lot lighting

Side-by-side comparison of halogen and LED MR16 in Naval Exchange Jewelry Department

These lighting projects were funded under the following: Utilities Energy Services Contract (UESC), which is a utilities financing vehicle, and under the American Recovery and Reinvestment Act (ARRA) of 2009 (stimulus funds).

Naval Base Ventura County is the Navy's Energy Showcase Base for the West Coast, which is an ongoing test bed for new and emerging technologies.
